# TomoClub Website Privacy Policy Last Updated: August 1, 2025

This Privacy Policy ("Policy") explains how TomoClub, Inc. ("TomoClub," "we," "us," or "our") collects, uses, discloses, and protects the personal information of individuals who visit and interact with our public informational website located at <a href="www.tomoclub.org">www.tomoclub.org</a> (the "Website"). This Policy outlines our practices regarding the type of data we collect, the reasons for collection, and how we handle, store, and protect your personal information. Please note that this Policy only applies to information collected via our public Website and does not cover our Education Services, which include student games, Al literacy modules, professional development for educators, or any platform functionality that requires logging in. Those services are governed by a separate Education Services Privacy Policy, which can be reviewed when accessing the relevant platform or service.

### 1. Your Consent

By accessing or using the Website, you acknowledge that you have read and understood this Privacy Policy and that you consent to the collection, use, processing, and transfer of your personal information as described herein and in accordance with applicable United States laws. We may update this Policy from time to time to reflect changes in our practices, technologies, legal obligations, or for other operational reasons. If you continue to use the Website after the revised Policy has been posted, your continued use indicates your acceptance of those changes. While we may notify users of significant updates via email or Website banners, it remains your responsibility to review this Policy periodically. You may withdraw your consent at any time, subject to legal and contractual restrictions.

#### 2. What Information We Collect

TomoClub collects personal and non-personal information through various means when you interact with our Website. This includes:

#### 2.1 Information You Provide

We collect personal data that you voluntarily provide when you engage with the Website. # 4. Cookies & Tracking Technologies

To enhance user experience, analyze traffic, and support marketing initiatives, we use cookies, pixel tags, and local storage. Cookies help us remember user preferences, display customized content, and measure engagement with specific Website features. We use third-party analytics services such as Google Analytics and Hotjar to gain insights into user behavior, including navigation patterns, dwell time, and click-through rates. These services may set their own cookies on your device. You may disable or delete cookies through your browser settings, but doing so may impair some features or functionality of the Website. Please note that our Education Services do not employ behavioral advertising trackers on content targeted to minors, and we are committed to maintaining a responsible and privacy-conscious environment.

# 5. Sharing of Information

We are committed to protecting your privacy and do not sell your personal information to advertisers, marketing agencies, or any unrelated third parties. We may share information in limited circumstances, such as with trusted affiliates and service providers who perform functions on our behalf (e.g., analytics, cloud storage, marketing communications) under strict confidentiality and data protection agreements. We may also disclose information in compliance with applicable legal requirements or in response to valid law enforcement requests. Additionally, in the event of a business transaction such as a merger, acquisition, or sale of assets, your information may be transferred as part of that process. Any data that is shared for research or analysis purposes is first anonymized or aggregated so that it cannot reasonably identify an individual.

Once your data is no longer needed, we will securely delete or anonymize it in accordance with our data retention protocols. The retention period may vary depending on the type of data, the nature of our relationship with you, and the legal context in which the data was collected.

## 8. Data Security

TomoClub employs a range of industry-standard technical, physical, and administrative safeguards to protect your personal information from unauthorized access, disclosure, alteration, or destruction. These measures include data encryption during transmission and storage, regular security audits, secure coding practices, and restricted access controls. All employees handling sensitive data are trained in privacy and security protocols. However, no method of transmission over the internet or method of electronic storage is 100% secure. While we make every effort to safeguard your data, we cannot guarantee absolute security, and by using the Website, you accept these inherent risks.
